

How to prepare your manuscript

The article must be written in Armenian, Russian, or English. The manuscript must start with the title page that includes the title of the article (IN CAPITAL LETTERS aligned to the center), the full name of the author(s) (IN CAPITAL LETTERS - aligned to the left), the full affiliation of the author(s) (degree, position, institution, e-mail address, mobile phone number).

The manuscript should be submitted in B5 format (with a minimum of 10 and a maximum of 15 pages). The text should be in Sylfaen, 11pt, single-spaced, with the margins 2 cm from left, right, top, and bottom. The citations should be presented at the end of each page in a footnote, with continuous numbering. It is not allowed to cite materials from fake journals, news magazines, or textbooks. We highly encourage citing articles from journals with high impact factor. An example of correct citation is provided in the footnote¹.

Citations should be included in References at the end of the article, where each reference must be provided in its original language (Armenian, Russian, English) in alphabetical order. In the list of references, the sources must be presented in the following order:

- laws, concepts, legal acts, strategies, reports,
- books, articles,
- web pages.

Each part is grouped in alphabetical order. At the end of the manuscript, the abstract (200-300 words) and 8-12 keywords should be provided, both in Armenian, Russian, and English languages (before the abstract, the title of the article, the author's full name, and full affiliation must be provided).

For article citations: Poghosyan P, The tittle of article, The name of journal, year, volume, pages (in the References include the pages of the article in the journal)

For website citations: The tittle/name of website, hyperlink of website, the date of access.

The requirements of a manuscript and abstract design

The article must include the following mandatory parts:

- 1. **Introduction:** where the relevance, aim/purpose, and objectives must be presented.
- 2. **Literature review:** where the studies and works of other authors related to the topic are analyzed and presented.
- 3. **Methodology:** where the methodological framework (implemented methods and data used) is presented.
- 4. **Analyses/Discussion:** where the main analyses and their results are presented.
- 5. Scientific novelty.
- 6. **Conclusion:** where the main findings of the article and their implications are presented.

The abstract is designed in three languages

(Armenian, Russian, and English) and contains the following mandatory parts:

- The relevance of the article.
- The aim and objectives.
- Methodology.
- Scientific novelty.
- The main findings.
